A number of companies have expressed interest in TCST and active negotiations are in progress with one company to license the manufacture and distribution of TCST under our pending patents.

One rendering company has been licensed under our pending patents to produce and distribute the fat-containing admixture for cement products. But despite the interest and enthusiasm expressed at the TALENT seminars held last December we have not yet licensed an NRA or FPRF member to produce TALENT.
